# Customer Overview

Munch is a mission-driven digital marketplace helping fight food waste by connecting consumers with unsold food from local restaurants, grocers, and bakeries. Operating across Europe, Munch must report seller transactions under the EU's DAC7 and OECD's MRDP framework.

## The Challenge

In 2023, Munch was already filing reports in Czechia and Hungary, but workflows were manual, error-prone, and time-intensive. With expansion ahead, they needed to simplify and scale quickly.

**Manual formatting and validation of large data sets**



**Jurisdiction-specific XML and government rejections**



**Internal pressure from expanding reporting volume and new markets**
